Age Categories

Juniors: born in 2009, 2010, 2011

Cadets: born in 2012, 2013, 2014

Participants

Proof of membership by valid national Federation passport with ETU/WT membership. All contestants must present their passport or identification card during weigh-in to verify their age and nationality. All participants must be holder of a valid 2026 WT Global License. Contact your MNA responsible for questions about this WT license. Onsite registration for WT license is not possible.

Qualification

Cadets & Juniors male/female from 4. Kup. All participants (athletes and officials) require a WT Global Licence and must be member of a National Taekwondo Federation. This membership must be proved during registration by providing a valid WT Global licence.

Insurance

Each participant assumes personal responsibility for risks and accidents related to participation in the tournament and must be insured against accidents. The organizing committee and Krasniqi Taekwondo decline all responsibility.

Competition Rules

The official WT Competition Rules will be used. The tournament will be based on Single Elimination. Instant Video Replay (IVR) will be used for all matches.

Equipement

All participants bring their own protective equipment (gloves, forearm protectors, leg protectors, private parts). The tournament provides **Daedo G3 electronic** chest and head gear protectors. For hygiene reasons, all participants must bring their own Daedo foot protectors.

Recognized Brand

Participating contestants are required to wear WT-recognized doboks and WT-recognized protective equipment. The latest version of WT-recognized manufacturers' list is available at the website of WT: <http://www.worldtaekwondofederation.net/recognized>

Protest

Only the official coach is allowed to protest, immediately after the end of the contest. An amount of € 200 (Euro) will have to be paid for each protest. The decision of the referee chairman is final.

Awards

- Medal for competitors with a result: 1 Place / 2 Place / 3 Place
- Team cup Cadet / Junior / All Categories : 1 Place / 2 Place / 3 Place

Coaches & Referees

Coach eligibility requirements

1. Minimum age of 18 years.
2. Holder of a valid 2026 WT Global Official Licence.
3. Coaches are not allowed to wear a dobok — appropriate clothing (training gear, sneakers) is required.
4. One (1) coach for every 4 athletes — coaches receive a non-transferable accreditation for the sparring area.
5. Trainers cannot assume a coaching position and have no access to the Field of Play.

Referees

All referees will be contacted and invited by the Referee Committee.

Hotel and full board accommodation will be provided for international referees.

Registration

Registration fees

100 Euro Entry Fee via Bank Transfer: each contestant must pay 100 Euro via bank transfer to the account below **by the deadline of 01.12.2026**. The transfer must be completed without incurring any costs for the organizer.

130 Euro Entry Fee after the deadline: registrations after 01.12.2026 cost 130 Euro per contestant.

50 Euro Change of Weight Category Fee: contestants must pay 50 Euro to change their weight division.

If the athlete registered online (<https://worldtkd.simplycompete.com>) does not take part in the competition for some reason, but he/she has not been removed from the list of participants before the deadline (01.12.2026), his/her team official must fully (100%) pay his/her entry fee for participation. Entry fee is not refundable at any time after the deadline! You have to enclose a copy of the transfer with the application. Entry fees must be paid on the account below.

Antidoping

Agency (NADA), the World Anti-Doping Agency (WADA) and the World Taekwondo Federation (WT). The competitor accepts with the application the anti-doping rules of the National Anti-Doping.

Liability

All participants take part at their own risk, assume personal responsibility for any risks and accidents related to tournament participation, and must have accident insurance. By registering, all participants expressly release World Taekwondo, the European Taekwondo Union, Swiss Taekwondo, Krasniqi Taekwondo and the Organizing Committee from any and all liability. The registration implies that participants agree to take responsibility for themselves and release others from any liability arising directly or indirectly from the Krasniqi Open events. By registering, the responsible parties expressly agree to the disclaimer of liability. All participants must bring their own documents and forms for any medical treatments in Switzerland. All participants and visitors need a valid ID (valid passport or other official ID). By participating, participants accept the agreement with NADA/WADA (National & World Anti-Doping Agency).
